UPCOMING DEADLINES AND ITEMS OF IMPORTANCE

Pobal compliance visits and Workshop March 9th

Pobal will be commencing compliance visits to services in receipt of CCS funding for the 2017/18 cycle shortly. Attention should also be drawn to the notice previously issued by the DCYA and posted on the PIP Portal on 27/10/2017 which outlines requirements for maintaining attendance records and registering children on PIP during the snapshot window.

The Pobal compliance visit will continue to include a cross check between PIP registrations and attendance during the snapshot window. Any identified discrepancy will need to be amended and may subsequently result in a negative financial adjustment to the service.

The programme is designed to enhance inclusion of children with additional needs in early year's settings through the development of the role of Inclusion Co-Ordinator (INCO). The programme was introduced as part of the Access and Inclusion Model (AIM) in 2016. You may be aware that settings employing a LINC-qualified INCO are entitled to receive additional capitation as part of the ECCE programme. Access and Inclusion Model (AIM)

Access and Inclusion Packs

Roscommon CCC have been working closely with the DCYA to deliver the Diversity Equality and Inclusion Guidelines training and to provide parents and service providers with information and signposting on the Access and Inclusion Model.

The DCYA are currently assembling access and inclusion packs for early childhood services. Roscommon CCC have provided the DCYA with the relevant information regarding services who have participated in the Diversity, Equality and Inclusion training. It is expected that these inclusion packs worth approximately €500 will be distributed to childcare over the coming weeks.

A further development under the Access and Inclusion model is a new programme of specialised training for Early Years Practitioners will be rolled out in 2018. The first round of training is Hanen Teacher Talk, which is a certified 3 day course which will be delivered by Better Start Early Years Specialists. Better Start are collaborating with Teacher Education Centres around the country to ensure local delivery of training. The first round of training will begin in March and April 2018 in Cork, Dublin, Kildare, Leitrim, Limerick and Wexford and will take place on one Saturday per month. ECCE services in receipt of AIM targeted support (Levels 4-7) will be invited to apply. Further training courses will be available throughout 2018. Have you completed a major award at level 7, 8 or 9 in Early Childhood Care and Education on the National Qualifications Framework? If you completed the award in 2013, 2014, 2015, 2016 or 2017, please contact Roscommon CCC on 094 9622540 or info@roscommonchildcare.ie for further information or download the application form from our website on the link below.

The Department of Children & Youth Affairs (DCYA) will re-open the Learner Fund Bursary (announced early 2017) to Early Years practitioners who have completed a major award in Early Childhood Care and Education at Level 7, Level 8, or Level 9 qualification on the National Framework of Qualifications since the inception of the Learner Fund (2013). This qualification must be on the DCYA Early Years Recognised Qualifications list. The bursary amount will be €750. Roscommon County Childcare Committees (CCC) will process/appraise Learner Fund Bursary applications. In order to apply you must:

- Have a Qualification which is on DCYA Early Years Recognised Qualifications list
- Have a graduating certificate. If your certificate does not have the full name of the course a transcript will be required to confirm the course was ECCE. For example NUI certificates in Latin state that the holder received a Bachelor of Arts but not what subject it is in.
- Have been working in a registered Early Years' Service prior to beginning their course
- Be currently working in a registered Early Years' Service
- Have submitted a completed application form (along with all relevant documentation) to us no later than **5 pm on Wednesday 14th March 2018**.

Information Updates

DCYA Updates throughout the adverse weather March 1st and 2nd 2018



The National Emergency Coordination Group (NECG) on Wednesday February 28th following the issuing of a Status Red weather warning in some parts of the country. Conditions were expected to worsen over Thursday and Friday in parts of the country and the NECG advised that roads should be avoided in Status Red areas due to expected treacherous conditions. DCYA advised childcare services

that local decisions should be taken based on the weather status in their part of the country. In making this decision DCYA strongly advised that services have regard to any Met Eireann weather warnings that were put in place, particularly when a red warning is in operation, the availability of transport, the accessibility of roads and whether schools in the area were open. Minister for Children and Youth Affairs, Dr Katherine Zappone commented:

“The welfare and safety of children, staff and parents is paramount and we urge everyone to be safe during this time and to be mindful of their local situation with regards to transport and school closures in their area”. The safety of children, parents and staff is of utmost importance and we are aware that some services took the decision to close their services on foot of the snowfall in parts of the country.

RSA Check it fits



This March the RSA's Check it Fits service will be visiting County Roscommon. It is the law that all children under 150cms or 36kgs must use a child car seat appropriate to their weight and height. In Ireland as many as 4 out of 5 child car seats are incorrectly fitted which can lead to serious injury or even death in a collision. Since October 2013, the RSA's 'Check it Fits' Service has checked over 30,000 child car seats and restraints in Ireland. The Check it Fits service is quick, it's easy, it's free. On the day the experts will advise on how to fix any problem, demonstrate how to fit the restraint correctly and answer any queries participants might have. Experts aim to put parent's, grandparent's and guardian's minds at ease that their child's car seat is safely and securely fitted in their car.
