#### **Covid Case Support Helplines**

There are two helplines available to services who have a suspected or confirmed case of Covid-19 in their service.

- 1. The HSE have a helpline to advise service providers if they have been informed of a Covid-19 case in a child or a staff member. The number is 01 511 9777 It is open Monday -Friday 8.30-4.30 and 10-4.30 Saturdays, Sundays, and Bank Holidays.
- 2. For those services who need support on engaging with the relevant authorities due to a suspected or confirmed case of Covid-19, there is an out of hours helpline. The number is 1800 940 341. The service will be available Saturday, Sunday, and Bank Holidays from 10.00 –13.00 and 13.30 –16.00.

Tusla online DLP Briefing Session 19th May 2021 to be rescheduled due to Cyber-attack - new date announced.

Unfortunately, due to the recent cyber-attack and the impact this has had on Tusla IT systems, Tusla have informed Roscommon CCC that they will not be able to proceed with the Tusla online Briefing Sessions on the Role and Responsibilities of the DLP on 19<sup>th</sup> May as planned.

#### **HSE** cyber attack

Earlier this week, you would have received a communication from Tusla regarding procedures to follow whilst their computer systems are out of action. The main points are as follows:

The Early Years Inspectorate Registration Office system has been shut down as a precaution. Therefore, internal systems and the portal are down, and the staff do not have access to email.

- If you need to submit a **notifiable incident** or if you have a query regarding an existing incident, please call Tusla on 061 461706 or 061 461711.
- New registrations have been temporarily suspended. Liaison with those who have already submitted a registration will continue by phone.
- ▶ New school age registrations have also been suspended. If you have submitted a school age registration, the time limit on resubmissions has been suspended. Tusla staff will continue to liaise with services who have already submitted registrations by phone.
- Cessation/change in circumstance forms should not be submitted. Keep on file and wait for updates.

We have attached a **poster** listing the main contact phone numbers that can be used.

Anyone with **child protection and/or welfare** concerns should continue to follow their policies and procedures and seek informal advice or make reports through the dedicated contact points, which can be found at this link <a href="https://www.tusla.ie/get-in-touch/duty-social-work-teams/">https://www.tusla.ie/get-in-touch/duty-social-work-teams/</a>

### Interim Covid-19 notification procedure

If you have a case of Covid-19 within your service but haven't heard from the HSE, contact the HSE Childcare facility line on 01 511 9777. They will give you the number to contact the local Departments of Public Health. These numbers are subject to change at the moment, so ring the HSE childcare line first to make sure you are calling the right number.

If someone is symptomatic but has not yet got a test result, they should continue to self-isolate. Noone with Covid-19 symptoms should be in the service. You don't need to exclude close contacts until a confirmed result is received. Whilst there is a slight delay, positive results are being rapidly provided to patients.

Calls to the HSE Childcare facilities line or Departments of Public Health directly are for confirmed cases only please.

#### **Child Protection and welfare Concerns**

Q. What should I do if I have a Child Protection and Welfare Concern if the Tusla Portal is down?

**A.** As you may be aware, there has been a cyber-attack on the HSE's IT system. This has resulted in the Tusla Portal, through which Child Protection Reports are generally made, being unavailable. In the absence of the Portal, those with Child Protection and Welfare Concerns should continue to follow their organisational procedures and seek informal consultation or make reports or through the Dedicated Contact Points, which can be found at this link <a href="https://www.tusla.ie/get-intouch/duty-social-work-teams/">https://www.tusla.ie/get-intouch/duty-social-work-teams/</a>

All practitioners should continue to ensure that the safety and welfare of the child remains of paramount importance and that all concerns are reported to Tusla and An Garda Síochána, where appropriate.



#### The Little Library initiative

The Little Library initiative has been launched by DCEDIY. The bags will be with the libraries next week and the librarians will then start making contact with the services in their area asking the services to come and collect the bags.

There are two book bag types produced containing five books each:

- a book bag for general ELCs containing one Irish title and the remainder in English
- a book bag of all Irish titles for providing to the Naíonraí.
- each bag contains 5 story books for children selected by the national library service for children up to five years.

The bag also contains a number of resources from the libraries including a service library card and a guide to that local library. There are also two specially developed booklets developed by Barnardo's for the First 5 Little Library project, one on using books and stories with children under 5 and the other a guide to developing a little library in the early learning and care setting.

Early Learning & Care settings are allocated bags according to the number of children in the setting and services with less than 38 children are allocated one bag, services with 39-100 children are allocated two bags and services with 101 plus children registered are allocated 3 bags.

A second provision of Little Library Book Bags is planned to take place in the autumn to tie in with Children's' Book Festival and it is hoped that SACs will be included at that time.
