Grant Programme for Improved Ventilation 2021-

Applications will be open from the 16th of December to the 7th of January 2022

Applications **cannot be submitted outside this application window. All applications must be submitted on the HIVE.**

The amount of grant which is paid to each Early Learning and Care and School Age Childcare Service is based on the number of individual children registered in a service on one or more DCEDIY programmes on the 24th of November 2021. The number of individual children registered will be taken from Early Years Portal and PIP systems hosted by Pobal.

To be eligible for funding, you must have had at least one registered child on one of the following schemes on the 24th of November 2021:

- National Childcare Scheme (NCS)
- Early Childhood Care and Education (ECCE)
- Community Childcare Subvention Programme Plus (CCSP)

Payment of the grant:

Payments to approved applicants will commence from the **24th of December** and will occur weekly thereafter. Applicants will be paid 100% of their grant allocation and will receive their payment within 10 working days of submitting their application.

The amount of funding each service is allocated under Grant Programme for Improved Ventilation 2021 is as follows:

Number of children registered on DECDIY Programmes	Grant Allocation €
1-49	€1,500
50-9	€3,000
100+	€4,500

NCS Service Calendar (adding closures)

If your service is closed over the Christmas and New Year's period, you must mark the closures on your NCS service calendar on the Hive accordingly - this must be done in advance of the Christmas period, NCS calendars cannot be adjusted retrospectively. You must also note whether it is a subsidised (paid) closure or not. Services are entitled to up to 10 subsidised closures per programme year.

NCS Non-Term Hours

Non-Term hours can be used to cover the Christmas period for childcare needs when schools/ECCE are closed. When Non-Term hours are added to an NCS claim, the parent receives a notification on their portal and needs to be confirmed by them for them to come into effect. For guidance on adding Non-Term hours to NCS claims, please see the 'How to add Non-Term hours to an NCS claim' heading of the [NCS Child Registration Guide](#) on the Hive.

Remember: if you are using the attendance tracker available on the Hive [HERE](#), for Non-term weeks you will need to update the 'NCS hours claimed' column with the child's Non-Term hours. This will

ensure that the tracker will generate alerts correctly against their attendance. You will need to revert to their term hours when term resumes.

Important: Changes cannot be made to service calendar opening hours or claimed hours once a return for that week has been submitted on the Early Years Hive.

NCS Weekly Returns

As per the [NCS Funding Agreement 2021-22](#), NCS returns must be submitted on the Early Years Hive each week. Returns become available from the last day (Sunday) of the reporting week and must be completed by the following Tuesday and are based on the previous week's attendance.

If a return is not submitted within the required timeframe, all subsidy payments will be suspended until it is submitted. All service providers should ensure any outstanding returns are submitted before the end of the year. For guidance on returns, please see the [NCS Attendance Returns Guide](#) on the Hive.

If your service is closing over Christmas, returns for these weeks still must be submitted. If you are unable to submit returns during a closure period, please see the below section on Bridging Payments.

NCS Bridging payments

A 'Bridging Payment' is available to service providers during periods of subsidised closure, if they are unavailable to submit their weekly NCS return i.e., Christmas holidays, mid-term breaks, etc.

When submitting the NCS return that is two weeks before the subsidised closure period, the Hive recognises the closure coming up and asks the following: *"You have an upcoming closure, do you want to request a Bridging Payment for the dates from "X" to "Z"? (Yes/No)"*

If Yes is selected, the payment is made during the week the service is closed i.e. when they are unable to submit their returns. The service must then submit "Fast returns" for this period when they return after the closure.

Early Learning and Care (ELC) & School Aged Childcare (SAC) services in County Roscommon received support in the following areas:

Services in County Roscommon were supported regarding:

Regulatory compliance: Tusla & Governance compliance: Always Children First, Safeguarding Statements, Compliance with Pre-school regulations, governance supports, Tusla Re-registration, Pre & Post Tusla inspection.

Programme compliance: National Childcare Scheme programme rules, Registrations and Programme readiness, Capital funding applications, Recruitment, Covid compliance & guidance, .

Signposted ELC/SAC Services to First 5, My CCC, Portal Announcements, Transitions project initiative, Local & National agencies.

Pre development supports: 2 new ELC and 1 SAC Services opened. continuous pre-development supports to ELC & SAC service to increase capacity in the county.

Supporting refugee children & families access ELC/SAC: Supported/ chaired the local inter-agency management committee & supported the further development of an ELC service onsite Emergency Reception & Orientation Centre (EROC).

100% ELC/SAC services were supported to complete their Tusla re-registration process.

Roscommon CCC supported services with Always Children First training & queries and signposted to Tusla compliance and Safeguarding statements

100% of ELC & SAC services received ongoing one to one Covid-19 support & supported the delivery of the National Covid-19 Support Helpline for ELC & SAC providers.

Roscommon CCC supported services with Covid related payment supports and information as well as the extension of the Employment wage subsidy scheme.

100% ELC & SAC services were supported with National Childcare Scheme (NCS) & Programme implementation platform (PIP) information & training

100% ELC/SAC services received one to one support in relation to financial planning/sustainability and developing fee payment policies and supported with programme registrations.

Childcare Capital Programme : Early Years Childcare Services in County Roscommon received Capital funding to support Fire Safety, outdoor works & ventilation. All services were supported by Roscommon CCC throughout the application process.

Learner Fund applications were approved in line with National Guidelines

Applications were received and processed for the First Aid Responder (FAR) Funding in 2021. A total of **€1515.00** was distributed to eligible services during 2021. Overall, during the three year programme, a total of **€10,418.74** was distributed in the County.

ELC & SAC Services were signposted information regarding regulatory and programme compliance and updates, Governance information, Aistear & Siolta, Better Start, Linc, First 5, My CCC, Local & National initiatives, through **social media & Roscommon CCC weekly bulletin**.

100% of ELC services were informed of Access & Inclusion model (AIM).

Supporting the National Workforce development Plan:

Signposted the national workforce development plan to ELC/SAC Services.

Roscommon CCC facilitated 1 DCU student work placement

ELC/SAC services were supported with recruitment during **Roscommon CCC recruitment week**. Local & National Colleges & Galway/Roscommon Education Training Board (GRETB) collaborated with Roscommon CCC to promote career's in the Early Learning and Care Sector.

Training/ information supports to ELC/SAC services included: Tusla Always Children First - Deputy & Designated Liaison persons & mandated training. Covid-19 compliance, Capital, Pobal Compliance, Governance compliance, Tusla re-registration, Fees lists and Service Calendar, National Childcare Scheme, ECCE & Legacy Scheme programme readiness and Transitions project initiative,

National Childminding Action Plan for childminding :

Roscommon CCC welcome the launch of the National Action Plan for Childminding. There is 1 Tusla registered Childminder & 5 Voluntary notified childminders in County Roscommon

Childminders received imaginative play resource packs as part of the imaginative play initiative hosted by Roscommon CCC. Pediatric First Aid Training was also hosted by Roscommon CCC for Childminders.

Parent & Toddler Group Grants :

There are 15 Parent and Toddler Groups in County Roscommon. 4 Parent and Toddler Groups received funding under Parent & Toddler Grant initiative. 1 new group set was supported by Roscommon CCC. Funding Allocated to Parent & Toddler Group Grants 2021: **€3200.00**

Roscommon CCC Support to Parents:

100% of Parents who contacted Roscommon CCC were supported with the National Childcare Scheme (NCS), Early Childhood Care & Education (ECCE) programme , AIM, and Legacy Schemes through phone, email, information workshops and social media support.



2000 participants attended Roscommon County Playday 2021 which was held virtually. **400** playpacks were distributed to local Family Resource Centres & Emergency reception and orientation centre.

CHRISTMAS ACTIVITIES

Christmas recipes for kids

Cooking with the kids at Christmas is a really fun family activity. Bake up a storm with snowmen cupcakes Enjoy yourselves or share with friends as gifts.



Preparation time - **30 mins to 1 hour**

Cooking time- **10 to 30 mins**

Serves- **Makes 12**

Ingredients

For the cupcakes

- 200g/7oz [caster sugar](#)
- 175g/6oz [plain flour](#)
- 50g/1¾oz [cocoa powder](#)

- 1½ tsp [baking powder](#)
- ½ tsp [bicarbonate of soda](#)
- pinch salt
- 100ml/3½fl oz [sunflower oil](#)
- 2 large free-range [eggs](#)
- 2 tbsp [soured cream](#)
- 125ml/4fl oz boiling water

For the buttercream

- 200g/7oz unsalted [butter](#), softened
- 400g/14oz [icing sugar](#)
- 1–2 tbsp [milk](#)

To decorate

- 100g/3½oz white ready-to-roll [fondant icing](#)
- orange [food colouring](#) paste
- red [food colouring](#) paste
- 12 white [marshmallows](#)
- black writing [icing](#) tube
- 2 tsp [desiccated coconut](#)
- 12 pretzel sticks, broken in half

Method

1. Preheat the oven to 170C/160C Fan/Gas 3½ and line a 12-hole muffin tin with paper cupcake cases.
2. Sift the sugar, flour, cocoa, baking powder, bicarbonate of soda and salt into a large mixing bowl. Stir in the sunflower oil, eggs, and soured cream until smooth. Add the boiling water and beat again until silky smooth.
3. Scoop the batter into a jug and pour evenly between the paper cupcake cases. Bake for 20–22 minutes until well risen and a wooden skewer inserted into the middle of the cakes comes out clean. Leave to cool in the tin for 5 minutes, then transfer to a wire rack to cool completely.
4. To make the buttercream, beat the butter until pale and light, then gradually stir in the icing sugar and milk until smooth.
5. Make the snowman noses with 25g/1oz of the fondant icing. Add tiny dots of orange food colouring paste using a wooden skewer and knead until completely orange. Roll into 12 small carrot shapes about 1cm/½ in long. Leave to dry for 30 minutes.

6. Tint the remaining icing red using the food colouring paste. Dust a work surface with icing sugar and roll into a neat 12cm/4½ in x 6cm/2½ in rectangle. Slice into 12 strips about ½ cm wide, to make the snowman scarves.
7. Use the black writing icing to draw eyes and a mouth onto each marshmallow and stick an icing carrot just below the eyes.
8. Spread the buttercream on top of each cake and press a marshmallow into the icing. Scatter over the desiccated coconut and push two prezel halves into each side of the cupcake for arms. Pipe black icing buttons onto the buttercream and wrap a red scarf around each marshmallow.
